1. An update on the re-opening of the Tourist Information Centre and changes to the arrangements for organising volunteer curators was received from Cllr Edgar Jones. He also reported on the meeting with representatives from County, Prime Cymru, Llandovery Partnership, and Menter Bro Dinefwr on 14 March. As a result of that meeting, a meeting of the Council was arranged for 25 March 2013.

#### 9. MATTERS ARISING / UNRHYW FATER ARALL

- The idea of providing a defibrillator for use in the community was considered further.
   Cllr Blud will make enquiries with the British Heart Foundation and the Ambulance Service to pursue the way forward.
- 2. Draft Proposals from the Local Government Boundary Commission for Wales for the future electoral arrangements for the County of Carmarthenshire, and the invitation to comment, were considered. The change was seen as reasonable and no further action was considered necessary.

- 3. An update on the request for a perimeter fence to be installed at the Green Lodge Play was received. There has been no update from County, but there should be by the next meeting.
- 4. An update on the Kidney Wales Foundation Walk for Life event on 24 March was received. Mr Glyn Evans has planned the walk and various organisations are contributing to the event. Cllr Dorothy Burgess was thanked for her work in organising the event.
- 5. The outcome of the refurbishment of the Swimming Pool was considered. Cllr Wright informed members that she had visited the pool and most of it is in very good order, and it is clean and tidy. The spa pool is not working, but this is attributed to the chemical balance in the water which causes problems.
- 6. The flooding problem for property on the Cilycwm Road and in Stone Street, caused by the Bawddwr, was considered.
  - It was **resolved** that letters be sent to County and the Environment Agency in an effort to obtain a lasting solution to the problems.
- 7. A report on the first meeting of Llandovery Walkers are Welcome Group was received and noted. Cllr Edgar Jones informed members that an event to launch the scheme officially is in the hands of Huw Parsons at County Tourism. It was agreed that a letter of thanks be sent to Mr Evans.
- 8. Nominations for Mayor and Deputy Mayor for the year 2013 -14 were proposed and ratified. It was **resolved** that Cllr Rees be the next Mayor. It was **resolved** that Cllr Wright be the next Deputy Mayor.
- 9. A letter from County Cllr Kevin Madge about the Armed Forces Community Covenant Grant was considered, and the celebration of Armed Forces Day was discussed.

It was **resolved** that the information be passed to the secretary of the Royal British Legion.

It was **resolved** that no further action is necessary.
