1. A meeting of the Committee was arranged for 6 June 2011 in the Heritage Centre at 7.00pm.

1. Cllr Thomas delivered a verbal report about the meeting on 6 May 2011 of the collaborative group formed to explore funding opportunities for the Heritage Centre.

It was **resolved** that the Town Council should take the lead in taking the project forward, and the matter was referred to the Forward Planning Committee.

2. A meeting of the Committee was arranged for 19 May in the Heritage Centre at 6.45 pm.

Re The Riverside Walk

The Clerk informed Members that he had been chasing progress on the issue of the clearance of the Castle mound and riverside walk, and had been informed by the Assistant Grounds Maintenance Manager (Assets) at County, that he will be meeting with the contractor who will be doing the clearance work to go through the details on site. Cllrs Smith, Jackson, Edgar Jones, Nigel Burgess, Thomas and Hudson asked to be informed of the date time of the meeting.

#### 9. MATTERS ARISING / UNRHYW FATER ARALL

1. The Committees and their membership were reviewed.

The list of Committee Membership was reviewed – Clerk to issue an updated list to all Members.

- 2. The Council's decision to sign up to The Covenant of Mayors Initiative was ratified, and the Mayor signed the form. Clerk to despatch the completed form to register.
- 3. Action to appoint formally a firm of solicitors to act on behalf of the Council, as and when required, was considered.

It was **resolved** that the Clerk contact leuan Morris-Dilwyns to establish their terms of business available to the Council, and also to invite Robert Christie of Hugh Williams Son & Co to a meeting to meet the Members.

- 4. The minutes of the meeting on 31 March 2011 of Llandovery and District Chamber of Commerce were received and noted.
- 5. The minutes of the meeting on 19 April 2011 of the Assembly Rooms Management Committee and the Statement of Accounts for the year ended 31 March 2011 were received and noted.
- 6. The notification of an application by Llandovery Chamber of Commerce for a Sustainable Tourism Grant for two information screens was received and noted. It was agreed that it is good the Council is being informed, and that the Chamber of Commerce is doing marvellous work.
- 7. In the absence of Cllr Ennion, the Clerk delivered his verbal progress report on action regarding Armed Forces Day on 25 June 2011.
  - Cllr Ennion had contacted the Warden of the College, which is unable to be involved this year. Cllr Jackson stated that he had attended two Armed Forces Day events last year and both were poorly attended. It was agreed that the focus is still on the Armistice Day event, which is well supported.

8. Cllr Dorothy Burgess delivered a verbal report and a printed summary to Members on the Prince's Foundation for the Built Environment workshop on 21 April. Five attainable goals had been identified at the workshop, for which a letter of support was requested.

With regard to tree planting, the point was made that this issue needs careful consideration to avoid wasted effort.

It was **resolved** that a letter of support be sent to the Prince's Foundation for the Built Environment.

9. The Mayor delivered a verbal report from the sub-committee which organised the Party on the Square on 29 April 2011.

The event was a great success and within budget with the donations received. Thanks were expressed to those Councillors and others who contributed to the event. The Clerk was asked to send "thank you" letters to donors and helpers. Cllr Jill Blud was thanked for both directing the event and allowing her premises to be used for the Headquarters for the event.

The system for ensuring that commemorative mugs were given to all the local children present was severely tested, and a different system will have to be devised for another such occasion. One newspaper had not mentioned the fact that it was the Town Council which funded and organised the event, and the Mayor would write to the newspaper concerned to inform them.

- 1. Letter from Ysgol Pantycelyn Action Group (YPAG)
  The letter was received only 2 hours before the meeting. The receipt of the letter was discussed, but no "new" decisions were (or could be) made. The resolution made at the meeting of the Council in June 2010 to support the approach by YPAG to a barrister to seek legal opinion was reaffirmed.
- 2. Cllr Hudson reported that he had been approached by residents about cars not stopping at the pedestrian crossing in Queensway. The paintwork on the road has worn. Clerk undertook to report to the police and make enquiries with the appropriate authorities.
- 3. Cllr Nigel Burgess reported that the black horizontal surfaces on the equipment at Green Lodge Play Area are powdering, and leaving black marks on the children's skin and/or clothing. Clerk undertook to report to County.
- 4. Cllr Wright reported that the Royal Mail Monument on the Brecon Road is to be repaired by a collaboration of Royal Mail Heritage, Brecon Beacons National Park Authority and Channel 4 TV.
