4. POLICE MATTERS & REPORT / ADRODDIAD YR HEDDLU - MATERION

PC Howie Davies was in attendance. He apologised for missing the last meeting and for not having the latest crime statistics, but crime in Llandovery remains low.

The Police are being proactive in connection with drugs offences. He reported that, following extensive CID enquiries, a person from the Gwent area has been charged in connection with the spate of dwellings burglaries which occurred in the town a year ago.

With regard to motorists failing to stop at the crossing in Queensway, he confirmed that the Police will deal with any contraventions, and that reports from independent witnesses will help. He confirmed that the Trunk Roads Agency is investigating the state of the crossing.

He undertook to bring statistics relating to motor bike offences to a future meeting.

The Mayor thanked PC Davies for attending, and he left the meeting.

Mr Robert Christie of Hugh Williams Son & Co attended to meet Members and answer questions about the provision of legal services for the Council.

7. COMMITTEE REPORTS / ADRODDIADAU PWYLLGORAU

7. 1. Finance Committee / Pwyllgor Cyllid

- 1. The minutes from the meeting on 6 June 2011 were received and noted.
 - It was **resolved** that the recommendations in the following items be approved:
 - 3 (allocation of Internal Auditor's invoice between Budget Headings 6 and 18),
 - 4 (to approve Sections 1, 2, and 4 of the Annual Return),
 - 5 (to not join the HOWLTA 200 Club and not to pay by direct debit),
 - 6 (to approve the draft Financial Risk Assessment for 2011/2012), and
 - 7 (to approve the revised Budget for 2011/12)

With reference to item 5, it was highlighted that the reason for not joining the HOWLTA 200 Club was that the Council is not allowed to gamble.

7. 2. Heritage Centre Committee / Pwyllgor Canolfan Dreftadaeth

The minutes from the meeting on 19 May 2011 were received and noted.
 Cllr Edgar Jones was thanked for his generosity in holding the party. Members were informed that more volunteers are needed, and Cllr Ennion offered to put an advert in the Post Office.

7. 3. Llandovery in Bloom Committee / Pwyllgor Gwyl Flodau, Llanymddyfri

- 1. The minutes from the meeting on 31 May 2011 were received and noted.

 With reference to item 2. of the minutes (Site Maintenance Budget), the Mayor reiterated that the money would stay in the budget until the possible action described in item 5 had been taken.
- 2. The Mayor informed Members that the three barrels in the Market Square had been replaced with three of the recently purchased barrels. Also, the new 5-tier planter was in place and planted, and Cllr Jackson was thanked for the plants and the planting.

7. 4 Forward Planning Committee / Pwyllgor Cynllunio Blaenllaw

- 1. Cllr Edgar Jones delivered a verbal report from the meeting with Ruth Coulthard (BBNPA) on 14 June 2011 to consider the development of the Heritage Centre, which was noted. Ruth Coulthard has undertaken to produce a specification to be put out to design consultants for quotation. A meeting with Ruth will be held on 29 June to approve the specification. County Council grants are available through which the Council will be able to recover the cost of the consultancy, estimated to be in the region of £10,000.
- 2. With reference to the Riverside Walk project, Cllr Ennion requested that a meeting of the Committee be arranged to meet with Gerwyn Thomas from County to review the clearance work by the Castle Mound, and to consider the way forward. Clerk to arrange.

8. TOWN CLERK'S REPORT / ADRODDIAD Y CLERC Y TREF

The Town Clerk's Report for June 2011 was received and noted.

9. MATTERS ARISING / UNRHYW FATER ARALL

1. A verbal report from the sub-committee which organised the Party on the Square was delivered by Cllr Blud, and donations to LADCA and the YMCA from the "surplus" funds were considered.

It was resolved that donations of £160 be sent to LADCA and the Llandovery YMCA.

Cllr Blud thanked all who helped in connection with the event.

2. How Llandovery will mark the Queen's Jubilee in June 2012 was considered.

It was **resolved** that a sub-committee be formed to consider this, and Cllrs Smith, Blud, Gina Jones, Wright, Dorothy Burgess, and Lovell volunteered to be members.

The outcomes of the recent application from Bon Marche Charcoal Grill for a premises licence were considered.

Cllr Hudson apologised to Members for giving incorrect information at the Licensing Sub-Committee hearing which he attended. The fracas on the night of the Royal Wedding was in Water Street, and Bon Marche was, in fact, closed. It was noted that the proprietor of Bon Marche had assessed the situation and had showed responsibility by closing his premises on that night.

One factor that the Licensing Sub-Committee took into account was that Water Street was considered to be residential whilst the area around Bon Marche was considered to be non-residential. An improved understanding of dealing with premises licence applications had been obtained from attendance at the Licensing Sub-Committee hearings.

It was **resolved** that for future applications for premises licences, a meeting will be called by the Clerk, after consultation with the Mayor.

4. A request from the Ysgol Pantycelyn Action Group (YPAG) for the Council to "front" the action to

pursue a Judicial Review was considered.

It was **resolved** that the Ysgol Pantycelyn Action Group be informed that the Council supports retaining the school, and reiterates the previous decision to provide support to the Group.

5. An invitation from Brecon Beacons NPA to make nominations for representatives on the Grants Panel managing the Sustainable Development Fund was considered.

It was resolved that Cllr Thomas be nominated.

6. A request from the County Council's Housing Scrutiny Committee for this Council's views on the Committee's Review of the Private Sector Housing Renewal Policy was considered.

It was resolved that the associated questionnaire be completed by Cllr Jackson and the Clerk.

7. A letter from The Purple Routes Play Project Team at CAVS was received and noted, and an invitation to attend the Project's official launch on 13 July 2011 was considered. Cllr Wright undertook to attend.

10. ACCOUNTS / CYFRIFON

It was **resolved** that the income in the aforementioned accounts be noted, and that the payments in the aforementioned accounts be approved.
