PC Howie Davies in attendance. The latest crime and incidents figures in Llandovery for October 2011 were conveyed to Members. PC Davies stated that in crime terms, October was largely uneventful. With regard to the recent Remembrance Day Parade and Service, PC Davies informed Members that the Police did not lay a wreath during the main Service at the Cenotaph because they were controlling traffic. The Police did lay a wreath later. Also, policing matters were complicated by the GB Rally event the same day.

The Police will provide a presence for the Christmas Lights Switch-on. In answer to questions:

PC Davies provided, as far as he was able, the outline details of a recent incident which occurred at a private party at the Rugby Club. The investigation is continuing.

He had no knowledge of a helicopter flying above the town at night recently.

There is a new system designed to keep the County Councillors and any member of the public informed about crimes in their area. The system can be used to inform interested persons about possible incidents, such as sheep rustling and scrap metal thefts. It was agreed that the Police Neighbourhood Watch Liaison Officer, Mr. Brian Jones, will address a future meeting.

The Mayor thanked PC Davies for attending, and he left the meeting.

### 7. COMMITTEE REPORTS / ADRODDIADAU PWYLLGORAU

### 7. 1. Queen's Diamond Jubilee Committee / Pwyllgor Jiwbili Diamwnt y Frenhines

The minutes from the meeting on 20 October 2011 were received and noted.
 Members were informed that a meeting with LADCA is taking place on 28 November.

2. The purchase of commemorative mugs was considered. A sample of a mug obtained by the Clerk was examined.

It was **resolved** that mugs be purchased from CommuniCorp in sufficient number to give one to each child attending Nursery or Junior school in Llandovery, within a budget of £2,000.

The Committee will establish the number to be ordered and inform the Clerk.

## 7. 2. Public Seating and Footpath Committee / Pwyllgor Eisteddleoedd Cyhoeddus a Llwybrau

1. The minutes from the meeting on 7 November 2011 were received and noted, and the recommendations in the minutes at items 3. 2 (the purchase of two seats) and 5 (the increase of the Committee's budget by £1,000) were considered.

It was **resolved** that the recommendations be approved en bloc.

1. The minutes from the meeting on 7 November 2011 were received and noted, and the recommendations in the minutes at items 5 (switching the supplier of electricity at the Heritage Centre), 6 (disposal of the broken shredder), 7 (the creation of a Budget Heading for expenditure relating to the Queen's Diamond Jubilee), 8 (revision of the Budget 2011/12), and 9 (that each Committee should meet in early January 2012 to enable the Finance Committee to consider all Budget Plans for 2012/13), were considered.

#### 9. MATTERS ARISING / UNRHYW FATER ARALL

- 1. Moving the time of the December meeting of the Council to 6.30 pm was considered. It was **resolved** that the December meeting of the Council commence at 6.30 pm.
- 2. A proposal from Carmarthenshire County Council to install a raised plateau on Broad Street in Llandovery to provide a safer crossing point for pedestrians, and to link the discontinuous footways was considered.

It was **resolved** that the Council object to the installation of the structure on the following grounds:

- a. The structure is unnecessary as a crossing point because pedestrians cross the road elsewhere.
- b. The structure will introduce a potentially dangerous hazard for (albeit illegally) speeding motorbikes
- c. The structure's potential as a device to reduce the speed of traffic was doubted.
- d. The structure will affect parking for the Church.
- 3. A draft Environmental Policy for adoption by the Council was considered.

It was **resolved** that the Policy be adopted with immediate effect.

4. A draft Equality and Diversity Policy for adoption by the Council was considered.

It was **resolved** that the Policy be adopted with immediate effect.

5. The procurement of artwork for the Town Crest for the Past Mayors Board and other applications, and the design, were considered

It was **resolved** that the artwork, based on the crest on the Town Hall wall, be procured for a cost of up to £300.

6. An verbal update on the Royal Mail coach monument was delivered by Cllr Ennion.

- 7. Notification from Brecon Beacons National Park Authority of the submission of documents and consultations associated with the BBNPA Local Development Plan was received, and an invitation to make representations was noted.
- 8. The contents of a letter from the Head of Street Scene at the County Council about joint working and winter preparedness were noted.
- 9. Notification from Carmarthenshire County Council about a consultation regarding the adoption of new powers that the Government have introduced which allows Local Authorities to exercise greater control over lap dancing clubs and similar premises was considered and noted.
- 10. The implementation of the residential parking scheme was discussed. Serious complaints about the scheme have been received from residents, and it is considered that there are major conflicts in implementation. The size of the lettering was likened to graffitti, and out of keeping with the town's conservation area status. The lettering is thick, and slippery when wet. A meeting with Cllr Ennion, the Clerk, and one of County's Traffic Engineers has been arranged.
- 11. To receive an update on the Llandovery Swimming Pool.

  Members were informed that a new floor is to be installed, and painting using labour provided by the Probation Service is planned. Temporary closure will be notified. It was hoped this will not occur in school holidays. It was encouraging that the work is being done, and a "re-launch" was suggested.

#### 10. ACCOUNTS / CYFRIFON

1. The schedule from the Clerk relating to income totalling £3,157.06, and payments totalling £2,378.22 for the period 1 to 31 October 2011 was considered.

It was **resolved** that the income in the aforementioned accounts be noted, and that the payments in the aforementioned accounts be approved.

- 2. The Consolidated Statement of Accounts and the Budget Summary as at 31 October 2011 were received and noted.
- 3. The resolution of the Finance Committee at its meeting on 7 November 2011 to approve the Annual Return for the year ended 31 March 2011 following external audit, was considered.

It was **resolved** that the Annual Return for the year ended 31 March 2011 be approved, and the Mayor authorised to certify Section 3 of the Annual Return.
