on Thursday 25th March 2010. There was a presentation from Julie Hannan of 'Ramblers Cymru'

about setting up and organising ramblers groups within communities. After the presentation,

Councillor Wyn Edwards reported on matters arising from the National Executive

Committee

meeting including the proposed allowances for community councillors. He noted that 57 councils

of the 72 in Carmarthenshire are affiliated to One Voice Wales. There was a discussion of

proposed agreements, or charters, between community councils and unitary authorities in which

responsibilities are further devolved to local councils. The Chair accepted Llandovery's offer of

hosting the next committee meeting on June 23rd and Cllr Burgess is liaising with Dr. Del Morgan
