## **CONTINUATION OF THE AGM**

Declaration by Councillors of any Pecuniary & Non-Pecuniary interests entered in the record book before commencement of the meeting.

Cllr Helene Lovell declared an interest in item 8A11 – Town Crier. Cllr Ivor Jackson declared an interest in item 10 – Planning.

#### DECLARATION BY COUNCILLORS OF ACCEPTANCE OF OFFICE

Councillors Helene Lovell and Nigel Burgess signed declarations of acceptance of office as Mayor and Deputy Mayor of Llandovery, respectively, on 14 May 2009 during the Mayor-making ceremony.

Cllr Edgar Jones offered congratulations to the new Mayor on taking office and for an enjoyable weekend of celebration.

#### 1. APOLOGIES FOR ABSENCE / YMDDIHEURIADAU

#### 2. CONFIRMATION OF MINUTES / CADARNHAU'R COFNODION

Re 11. Correspondence - Clerk omitted to record the reading out by the Mayor of the letter of thanks from former Clerk, Terry Leyman.

Cllr Nigel Burgess proposed that the minutes from the 20 April 2009 be accepted.
 Cllr Elizabeth Thomas seconded the proposal. All were in favour.

## 3. POLICE MATTERS & REPORT/ ADRODDIAD YR HEDDLU - MATERION

PC 101 Simms attended on behalf of PC Howie Davies.

#### 1. He reported as follows.

"Llandovery will cease to exist as a police station as from today and thereafter for a period of 12 weeks. This is due to a total refurbishment whereby the new police station will be located within the old police house in Towy Avenue. The level of service provided will not diminish as we will utilise the mobile police station on a daily basis for the township of Llandovery.

The police are aware of a communication dispatched to the council from the Chair of the B.O.B.B scheme. She remains keen to keep a good working relationship between councillors and is eager to point out that the scheme is in its infancy. However, I can announce that a total of two subjects have been banned already at the last meeting of the BOBB scheme. Those banned were dealt with for incidents of disorder. A further male has been issued with an interim ban by police recently for an incident of assault within a public house and criminal damage thereafter in the town. The Committee intend to implement a zero tolerance towards violence within public houses.

There were 6 recorded crimes reported during a 4 week period within the town, they include Criminal damage at the Post Office, the stated assaults and one of theft."

- 2. Cllr Jackson asked about telephone numbers to contact the Police. '101' should be used for non-emergency matters, and '999' for any perceived emergency.
- 3. Cllr Nigel Burgess conveyed PC Howie Davies's message of thanks to Cllr Gina Jones for her support over the last year, and his good wishes to the new Mayor.

The Mayor thanked PC Simms for attending, and he left the meeting.

# 4. MATTERS ARISING FROM LAST MEETING / MATERION - YN CODI

1. Re Police Matters 2. Issue concerning Ban or be Banned Committee.

The Mayor read out a letter from the Chair of the BOBB Committee (see 11.

Correspondence, item 11. below).

In the interest of building cooperation and understanding:

Cllr Ann Hughes proposed the Mayor and Cllr Gina Jones meet the Chair of the BOBB committee.

Cllr Edgar Jones seconded the proposal. All in favour.

2. Re Matters Arising - 3. Swimming Pool.

The Mayor reported that on 29 April 09, Clerk contacted Garry Price, Area Facilities Manager, by telephone, and was given a verbal update on the current situation. Clerk sent Garry an email on the same day, inviting him to this meeting, or at least to provide a written update of the situation. No reply has been received.

Clerk subsequently obtained from Gill Wright a copy of letter from Meryl Gravell Leader of CCC to Gill dated 20 April, confirming Garry's verbal update, which indicates new staffing rotas have been developed, and new Normal Operating Procedures and Emergency Action Plans are being implemented, which will allow the swimming pool to extend its opening hours. Agreement with the employees at the pool has been reached, and the process of recruiting the right employees is being followed.

In discussion it was viewed as remiss of Mr Price that he had not responded to the Clerk's email.

Cllr Haydn Hudson proposed a strong letter be sent to Mr Price on this point.

Cllr Elizabeth Thomas seconded the proposal. All in favour.

3. Re Other Matters arising, 2. - Concerns about the changeover status of Llandovery station and the "Up" platform.

The Mayor reported that Clerk contacted Gill Wright on 22 April to obtain background and was informed that the concerns are unfounded. The points will be replaced in 2010. Gill Wright who was in attendance as a public observer and addressed the meeting to confirm this, and stated she had an undertaking from Network Rail.

4. Re Other Matters arising, 3. - 'Code of Conduct' training.

The Mayor reported that the date for this event has been set – 10 June at Assembly Rooms – 7pm. Council members from the surrounding area have been invited.

All Councillors present except Cllr Edgar Jones stated their intention to attend.

- 5. Re Other Matters arising, 4. Costcutters, Stone Street planning irregularities. The Mayor reported that the Clerk spoke to Kevin Phillips, Planning Officer, on 28 April Kevin had already noticed the dishes and reported them to the Enforcement Team. Clerk then spoke to Conservation Enforcement Officer who informed Clerk that 'Instruction to remove' has been issued because planning permission will not be granted.
- 6. Re Other Matters arising, 5. Market Square maintenance.
  - The Mayor reported that the Clerk had sent letters to Head of Street Scene on 28 April, re Cobbles Cleaning Machine and Special Bins for Cigarette Machine. Acknowledgements received 9 May –
  - Cobbles Cleaning Machine issue forwarded to Area Manager (East Division) for attention and response.
  - Special Bins for Cigarette Machine issue forwarded to Cleansing & Refuse Team (East Division) for attention and response.

Cllr Ivor Jackson reported that the area under the arches has been painted and part of the paving repaired.

7. Re Correspondence, 4. - WAG - Invitation to visit the Senedd building Councillors asked to consider. Cllrs Thomas, Fontenoy, Burgess, and Gina Jones expressed an interest. The Mayor undertook to organise this.

8. Re Correspondence, 6. – Community Health Council – reply and invitation.

The Mayor reported that a reply to the Clerk's letter sent on 28 April 09 had been received on 13 May 09 from J S Skipper, Chief Officer. The Mayor conveyed the contents of the letter in which an offer to attend a future meeting of the Town Council to provide an update about the changes within the NHS in Wales was made.

Cllr Edgar Jones proposed Mr Skipper should be invited to an open meeting.

Cllr Maureen Williams seconded the proposal. All in favour.

Clerk asked to respond accordingly.

Cllr Nigel Burgess reported on the findings of the street lights inspection.

The potential advantages and disadvantages of switching off certain lights were discussed, considering economic benefit, safety, the community reaction, and the efforts to get the lights installed in the first place.

Cllr Thomas queried whether there were any areas where lights could be added – this to be reviewed in Committee – to meet on 2 June 09 at 7pm.

Cllr Robin Ennion proposed the issue be tabled until County has completed its review.

Cllr Nigel Burgess seconded the proposal. All in favour.

- 1. Cllr Ivor Jackson aired his views about the Mayor's memo issued prior to the meeting. The Mayor noted and responded to these views.
- 2. Cllr Robin Ennion raised the issue of ball games being played in the Market Square, and queried whether "No Ball Games" notices could be erected. Cllr Ivor Jackson undertook to investigate with County.
- 3. Cllr Phil Bridger raised the issue of ball games being played in the Car Park this was considered to be a matter for the police.
- 4. Tennis courts
  - a. Cllr Thomas raised the issue of locking the gate on the far side to prevent the courts being used as a short cut. The Mayor undertook to get a lock.

  - c. Cllr Jackson informed the meeting that County was hoping to obtain a grant to improve the courts, but unfortunately, this had fallen through. However, there is a possibility that a "Green Flag" parks initiative may be adopted and applied to Llandovery Park next year, and this would see a big improvement. Also, there may be the possibility of Town Council involvement in partnerships with such as the Tennis Club.
  - d. Cllr Ennion observed that some work needed to be done to clear the area of discarded old nets and football equipment, and make the area neat and tidy. Cllr Hughes suggested a sign to stop dogs. Cllr Jackson undertook to take these issues to County.

The Mayor informed Council that she would be visiting Rhys Prichard School the following morning, in full regalia, accompanied by the Macebearers, , and sought the views of whether to present the overseas visitors with a Llandovery Plaque. It was agreed that this should happen.
