# 8. TOWN CLERK'S REPORT / ADRODDIAD Y CLERC Y TREF

8.1 The Town Clerks Report was received and noted.

8.2 It was resolved that Executive Powers be delegated to the Town Clerk to resolve late/delayed payment issues at the Llandovery Business Hub.

8.3 It was resolved that the Town Clerk write to contractors working for the Council to remind them of the need to implement Safe Working practices.

# 9. MATTERS ARISING / UNRHYW FATER ARALL

9.1 A verbal report was delivered from the CIO by Cllr Wright. The CIO will accept possession of the Heritage Centre on a 99 Year lease from the Llandovery Town Council. It was resolved that a Working Group comprised of Cllrs Long, Wright, Logsdail, Blud, Jones and, the Town Clerk be formed to work through the details and formulate an action plan as soon as possible.

9.2 Cllr Long delivered a verbal update on the matter of Asset Transfer. It was resolved that a meeting of the Working Group would take place as soon as practicable in order to organise a facilitated Workshop in Pantycelyn Hall where, residents interested in the maintenance and management of the play grounds will be invited to develop plans for establishing Community Groups to take on the role. The target date for this Workshop is the School Half Term at the end of February.

9.3 An update on the Pantycelyn Hall Lease was received from the Town Clerk. A solicitor has been instructed to act on behalf of Llandovery Town Council to negotiate terms with Carmarthenshire County Council.

9.4 It was resolved that, having received no further observations or questions from Councillors or, from the Members of Neuadd Pantycelyn regarding the Amended Draft Lease received from the CCC Legal Team that, the Solicitors be instructed to finalise and sign the Pantycelyn Hall Lease.

9.5 It was resolved that the Town Council write to Lloyds Bank Senior Management inviting representatives to meet with the Town Council to discuss the proposed closure of the Local Branch. It was further resolved that a Public Petition be raised protesting the proposed closure.

9.6 It was reported that work on the Nant Bawddwr Culvert Project was being held up due to the wall surrounding the Town War Memorial being "Listed". There is also a problem in that so far SWTRA has been unable to establish ownership of the wall. Their inquiries continue.

### 9.7 Deliberate Deletion

9.8 It was resolved that, on behalf of the Council, the Town Clerk commission an Inspector to carry out a full Health & Safety check of the Llandovery Town Council property holdings, working practices and anything which may impact upon the Public Liability of the Council. 9.9 It was resolved that the matter of BBNPA use of the lower floor of the Heritage Centre be reviewed by the Working Group assembled under para 9.1 above.

9.10 The members were informed that a site meeting will take place at 09.00am on the morning of Monday 30 January with the Police and CCC to discuss placing a No-Left Turn Sign at the junction of Market Square and Stone Street.

9.11 A presentation on behalf of the Alzheimer Society, made by Marcia Vale was received by the Council. It was resolved that Llandovery would work towards acquiring recognition as a "Dementia-Friendly Community". It was resolved that the Town Clerk would take the lead in administrating the process.
