6. COUNTY COUNCILLOR'S REPORT / ADRODDIAD Y CYNGHORWR SIR

- 6.1 In October 2017 an application was submitted by County Councillor Handel Davies and Mr David Dyer following which It has been recently announced that Llandovery has been successful in being selected as hosts of the Urdd Eisteddfod in 2021. This is the first time in history that the largest youth festival event in Europe will have been held in Llandovery. 6.2 New brown signage symbols to each of the four main road entries into the Town have recently been installed. This will help to promote the facilities and raise awareness of the activities that are available in the Town and locality.
- 6.3 The Ogof Twm Sion Cati launch of the promotional information board and the walkway way markers signposting the pathway, is to be formally opened on Friday, March 22nd 2019 at the Dinas RSPB car park, Rhandirmwyn.

- 6.4 The planning application for the proposed development to relocate the Ysgol Rhys Prichard has recently been registered and subject to approval the works are scheduled to commence in June 2019.
- 6.5 Congratulations to Wyn Jones, Clynmawr, Llandovery on being selected in the Wales Six Nations squad for the forthcoming rugby international fixtures against England, Ireland, France, Scotland and Italy. Llongyfarchiadau mawr!

7. COMMITTEE REPORTS / ADRODDIADAU PWYLLGORAU

- 7.1 The minutes of a Meeting of the Finance Committee held on Monday 7 January were received.
 - a. It was resolved to approve the Draft 2019/20 Town Council Budget.
 - b. It was resolved to approve a 4.999% increase in the Precept Demand.
- 7.2 The Minutes of a Meeting of the Forward Planning Committee held on Tuesday 8 January were received.
 - a. It was resolved to draft a Work Schedule for the removal of weed from the pavements in high footfall areas of the Town and to put this out to Tender for pricing. No Expenditure has been approved.
 - b. It was resolved that a Work Schedule for the placing of bunting around the Town for Events be drafted and put out to Tender for Pricing. No Expenditure has been approved.
 - c. It was resolved that pricing be obtained for the possible replacement of the Bunting currently held by the Council. No Expenditure has been approved.
 - d. It was noted that there may be a requirement for the Town to make a contribution towards the Urdd Eisteddfod in 2021. No Expenditure has been approved. To be placed on the Agenda for February Meeting.
- 7.3 The Minutes of the inaugural meeting of the Sports Festival Working Group were received.
 - a. A further meeting with a number of external Organisations and Agencies will be held on Monday 28 January to explore the various options available.

8. TOWN CLERK'S REPORT / ADRODDIAD Y CLERC Y TREF

- 8.1 The Town Clerks report was received.
 - a. It was resolved to put the painting of the windows and doors of the Heritage Centre out to Tender following the cancellation of the Contract by the previous contractor. It was also stipulated that the colour was to be Grey.

9. MATTERS ARISING / UNRHYW FATER ARALL

- 9.1 The Council representative Trustee for Llandovery Heritage reported that, Llandovery Heritage CIO continue to work with PACH on a publicity and promotion campaign. Llandovery Heritage requested permission to enter the Heritage Centre and start work on the Museum prior to the signing of the new lease.
 - a. It was resolved that Llandovery Heritage be permitted to enter the Heritage Centre and commence work subject to them paying the utility bills.
- 9.2 It was reported by the Clerk that the Constitution for the Llandovery Parks and Playgrounds Community Group had now been signed by the Trustees. The Constitution will be submitted to the Charity Commission as part of the Registration Process.
- 9.3 There have been delays in completing the necessary changes to the new Heritage Centre lease due to the Festive Season and clearing the backlog of work that has arisen. Town Clerk to expedite the completion of the new lease in conjunction with the Council Solicitor.
- 9.4 It was reported that having consulted with Carmarthenshire County Council (CCC) regarding the enforcement of parking Regulations within the pedestrianised area of Market Street/Square currently being used a private car park, the Council have been informed that

- CCC will initially carry out a public awareness campaign after which the Parking Enforcement Officer will be tasked to ticket offenders.
- 9.5 A proposal to purge the Council Archives of files more than 7 years old was rejected in favour removing these files to a storage facility thereby freeing up working space in the Archive.
- 9.6 It was resolved to appoint Mr L. Llewellyn as the Internal Auditor for the 2018/19 Audit at a cost of £390.
- 9.7 The Council "One Voice Wales" representative delivered a verbal report of the recent Area Meeting Written Report is attached.
- 9.8 The drafting of an action plan to deal with the death of a VIP or Head of State was delegated to the Protocol Committee which will meet on Monday 4 February at 20:00hrs in the Town Hall following a Meeting of the Amenities Committee at 19:00Hrs the same evening.
